2 04-02-2023 Petitioner has prayed for the following relief/s :



- (i) For issuance of writ in the nature of certiorari for quashing of the order dated 14-12-2022 passed by the Principal Secretary, Industries Department, Govt. of Bihar in Appeal No. 233/2022 whereby the appeal preferred by the petitioner against the order of cancellation of allotment of land of the petitioner has been rejected.
- (ii) For issuance of writ in the nature of certiorari for quashing of the order contained in memo no. 1312 dated 05-09-2022 issued by the Deputy General Manager, Bihar Industrial Area Development Authority, Muzaffarpur Cluster whereby the land allotment cancellation order contained in memo no. 1936 dated 30-08-2007 has been revived.
- (iii) For restraining the respondent BIADA from taking possession of the land of the petitioner and allocating the land of the petitioner to any third party during the pendency
