Petitioner has prayed for the following relief(s):

“a) For issuance of writ in the nature of mandamus directing the respondent authority specially respondent no.4 to implement the direction issued by Respondent No.1 and Respondent no.2 vide letter bearing Letter no. 2965 dated 13.06.2019 and letter no.1560 dated 30.05.2019 respectively Whereby and Where under respondent no.1 & 2 after considering the report submitted by District Magistrate, Gaya and enquiry conducted by committee constituted by respondent no.4, directed respondent no.4 i.e. Municipal Commissioner, Gaya



Municipal Corporation, Gaya to make the payment of the admitted dues of petitioner against the supply of De- silting machine along with two number of Dump Tank.

b) For issuance of writ in the nature of mandamus directing the respondent authorities specially respondent no.4 to make payment of admitted dues of the petitioner ie. Rs. 1,52,86,000/- along with 18% interest, against the supply of De-silting machine along with two numbers of Dump Tank Whereas the petitioner made the supply of De-silting machine alongwith two numbers of Dump Tank as per work order issued by respondent corporation, but in spite of making supply of equipment the payment has not been made by respondent corporation without assigning any reason.

c) For issuance of any other relief or reliefs.”

Learned counsel for the petitioner seeks permission to withdraw the present petition.

Permission granted.

Present petition stands disposed of as withdrawn.
