The writ petitioner retired from service on superannuation as a Librarian of Sakti Sangha Library, Village – Dariapur, P.O. & P.S. Baishnabnagar, District – Malda, on 31st August, 2018. After his retirement, the first pension payment order was issued by the authority concerned on 12th October, 2018 and he received the gratuity and pensionary benefits on 7th December, 2018. Thereafter, after ROPA 2019 came into force on September 16, 2020, the revised pension payment order was issued on 8th March, 2021.

The petitioner's case is that though ROPA 2019 was implemented on September 16, 2020, he received the gratuity amount and revised arrear pensionary benefits in terms of the revised pension payment order on 8th March, 2021. Hence he seeks a direction upon the concerned authority to pay interest to him for the belated payment of revised gratuity and revised arrear pension amount.

Learned Counsel appearing for the petitioner submits that getting the pensionary benefits is the legal right of the petitioner and pensionary amount is his property. He further submits that as per the Nationalised Savings Scheme for senior citizens, any deposit is made by a senior citizen now

carries interest at the rate of 8% p.a. He further submits that had the petitioner received his pensionary benefits in time, the amount, which he would have received, would carry interest at the rate of 8% p.a. As such learned Counsel for the petitioner prays for interest at the rate of 8% p.a.

Having heard learned counsel appearing for the parties and on consideration of the documents annexed to the writ petition, I feel that the writ petition may be disposed of by passing the following direction.

Accordingly, the concerned respondent, especially the third respondent – the Treasury Officer, Malda-I, P.O. & P.S. Malda, District - Malda – is directed to pay interest at the rate of 8% p.a. on the delayed payment of arrear gratuity and pensionary benefits with effect from September 16, 2020 as per the revised pension payment order dated 8th March, 2021 till the date of final payment, within six weeks from the date of communication of this order.

With the aforesaid direction, WPA No. 14512 of 2023 stands disposed of. No order as to costs.

All parties are to act on the server copy of this order duly downloaded from the official website of this court.
