Affidavit of service filed in Court today be retained with the records.

The writ petitioner was a permanent employee of the Durgapur Projects Limited (in short, DPL) which is a Government of West Bengal enterprise.

He was superannuated from April 30, 2023. The gratuity dues of the writ petitioner aggregating Rs.7,35,417/- is not paid till date. The quantum of gratuity amount is not in dispute.

Mr. Sarkar, Learned Counsel appearing on behalf of the writ petitioner, prays for gratuity amount and interest on gratuity amount payable to the writ petitioner from May 1, 2023 (the date succeeding the date of retirement) till the date of actual payment.

The Learned Counsel appearing on behalf of the writ petitioner, also prays for earned leave of 207 days which has not been paid till date. He further prays for interest on the earned leave, due and payable to the writ petitioner.

The number of days of earned leave, due and payable to the petitioner is not in dispute.

The issue has been squarely settled by various Judgements passed by a Co-ordinate Bench of this Hon'ble Court.

Relying on the judgements on the same issue and considering the facts of the case it is directed that the writ petitioner is entitled to get gratuity amount and interest on the delayed payment of his gratuity dues from May 1, 2023 till the date of actual payment at the rate of 6% per annum.

The writ petitioner is also entitled to earned leave of 207 days and interest thereon @ 6% per annum from May 1, 2023 till the date on which the actual payment will be made.

The respondent authority/DPL is directed to pay the aforesaid payment within six months from date. In the event, the said amount is not disbursed within the stipulated period, the rate of interest will stand

enhanced to 10% per annum being the statutory rate under the payment of Gratuity Act, 1972.

With the directions aforesaid, the writ petition, being **WPA 23955 of 2023**, is **disposed of**.

Since no affidavits have been called for in the writ petition, the allegations contained therein be deemed not to have been admitted by the respondents.

Needless to mention, in case the petitioner has occupied the quarter granted by the employer after his retirement the occupation charges for the said quarter will be deducted from the retiral benefits that the petitioner is entitled to as per the extant rules and policies of the employer/DPL.
