authority, in the fitness of things, the impugned

Commissioner, Aurangabad Division, Aurangabad is
directed to decide the appeal as expeditiously as
possible.

4. The Act itself provides for a statutory period for disposal of appeal and the endeavour be made to comply with the same.

5. Rule made absolute in above terms.

6. The Writ Petition stands disposed of.
