**ORDER**  
**(9th December, 2023)**

1. These appeals are placed before the National Lok Adalat by the appellant-State.
2. Learned AGP for the appellant/State submitted that the above mentioned appeals are squarely covered by the Government Resolution dated 03/11/2016 with corrigendums dated 23/02/2017 and 13/08/2018

to the said Government Resolution. In turn, these appeals can be withdrawn as per the policy decision taken by the Government of Maharashtra. Accordingly, the State is withdrawing these appeals.

3. The learned AGP for the state submits that in some of the appeals, the state has already deposited the compensation amount. He further submits that if the amount of compensation is not deposited before this Court or before the Reference Court, then the same will be deposited in Reference Court within a period of six months from the date of this order. If the amount is not deposited within six months from today, then it shall carry the interest as per Section 28 or 34 of the Act as the case may be. After depositing said amount in the Reference Court, the claimants are entitled to withdraw the same. It is further clarified that in case, any amount is lying with this Court, then the same shall be transmitted to the Reference Court. The Reference Court shall disburse said amount to the claimants on their applications. The learned AGP further submits that in these circumstances, nothing survives in these appeals. Therefore, these appeals and application for condonation of delay can be disposed of as withdrawn by the State.

4. In view of the above, this group of appeals stand disposed of as withdrawn. No order as to costs.

5. Refund of Court fees be processed as per rules.

6. Pending Civil Applications, if any, stands disposed of.
