PER COURT :

1. Heard respective learned counsel for the applicants and respondents.
2. Ms. S.A. Kale h/f. Mr. A. B. Kale appears for the applicants submits that the matters arising out of the same acquisition in the First Appeal No.3060/13 and other connected appeals, claimants have assailed the award passed by the Reference Court. This Court has condoned the delay of respective days in the matters on the ground that the claimants were facing financial crisis at the relevant point of time. In the instant cases also the claimants are facing financial crisis and their lands are compulsorily acquired.
3. Learned AGP for respondent -State and respective learned counsel for acquiring body oppose the applications.
