A) ORDER IN CIVIL APPLICATION NO.7980 OF 2023:

1. Heard rival submissions.
2. The applicants are seeking permission to bring themselves on record in the appeal being the legal representatives of sole claimant i.e. respondent No.1 – Shridhar Laxman Karbhari (Hanamshetty), who admittedly died on 21/11/2014, by condoning the delay of 2926 days.
3. There is no strong objection from other side and considering the right to defend, the application stands allowed in terms of prayer clause-B and C.
4. The appellant - acquiring body is directed to carry out the amendment within stipulated period.
5. Application is accordingly disposed of.
