**O R D E R**

1. Mr. P. S. Patil, the learned AGP for Appellants State, Mr. Pravin Phulari, Sub Divisional Officer, Ahmedpur, present on behalf of the Acquiring Body and Mr. H. B. Nandagavale h/for Mr. V.G. Sakolkar, the learned Advocate for the Respondents/ Claimants in matters at Sr. Nos. 1 to 9, 17,18, 28, 31 and 920, are present today before the Lok Adala t.

2. On instructions, the learned AGP submits that these appeals are covered by the Government Resolution dated 03.11.2016 read with subsequent corrigendum dated 23.02.2017 and 13.08.2018. The Appellant-Acquiring Body seeks to withdraw the appeals in view of the said Government Resolution/policy.

3. As the matters are covered by the Government Resolution/Policy and can be permitted to withdraw, it is desirable to condone the delay. For the reasons stated in the applications, the delay is condoned. The office is directed to register the first appeals.

4. In view of the Government Resolution cited above, all the first appeals are

disposed of as withdrawn. The X-objections to proceed further in accordance with law.

5. The Respondents/claimants shall be at liberty to withdraw the amount deposited in this Court alongwith accrued interest.
6. Court fees be refunded as per Rules.
7. Award be drawn accordingly.
8. Pending Civil Applications also stand disposed of.
