1. Issue notice to respondents. The learned counsel Mr. Sudhir Bhalerao waives service for respondent - acquiring body in some of

the matters and the learned AGP waives service for State-acquiring body in remaining matters.

2. Heard rival submissions.

3. The respective applicants are seeking condonation of delay periods mentioned in these applications, which appears to be caused due to their poor financial condition.

4. The learned AGP as well as the learned counsel for the acquiring body in some of the matters strongly opposed the applications on the ground that no reasonable cause is mentioned for condoning the delay periods.

5. However, considering the statutory right of the applicants and for the reasons stated in the applications, the applications are allowed and the delay periods mentioned in these applications stand condoned subject to condition that the applicants shall not claim any interest for the periods of aforesaid delay.
