A] ORDER IN CIVIL APPLICATION FOR
WITHDRAWAL

1] The present Civil Applications are filed to
withdraw amount deposited by the appellant in this Court.

2] The learned counsel for the applicants has
produced order dated 18th August, 2023 passed in Civil
Application No.10211 of 2023 in First Appeal Stamp
No.7617 of 2022 and other connected matters. The learned
counsel for the applicants submits that in similarly placed
matters, this Court permitted the applicants to withdraw the
entire amount of compensation deposited in this Court in
view of the fact that small pieces of land of the applicants
