PER COURT :-

1. The Writ Petitions at serial Nos. 901 to 917 are not on board. By consent of the parties, taken on board.
2. The grievance of these petitioners is only with regard to excess charges levied upon them with regard to allotment of the embarkation point from Aurangabad as compared to the charges payable for taking the Haj flight from the Mumbai airport. It is contended that as excess amounts have been charged to these petitioners, their pending representations with Respondent No.1 – Haj Committee need to be decided at the earliest.

3. In view of the above, all these **petitions are disposed off.**

4. We direct Respondent No.1 to consider the request of all these petitioners for a change of embarkation point from Aurangabad to Mumbai or to charge the same rates as are chargeable at Mumbai while allotting the embarkation point at Aurangabad. The petitioners will once again forward their same representations to Respondent No.1 on the e-mail address mentioned in the Petition within fifteen (15) days from today. Thereafter, Respondent No.1 would follow the due procedure laid down in law and decide the representations of the petitioners by following the due procedure laid down in law within a period of sixty (60) days from the date of receiving the e-mailed representations.

5. In the event, the petitioners are found to be entitled for a refund, Respondent No.1 would consider the said request for an early refund.
