1. Heard rival submissions.
2. The respective applicants are seeking condonation of delay periods mentioned in these applications, which appears to be caused due to their poor financial condition.
3. The learned A.G.P. in all these matters as well as learned counsel appearing for the acquiring body in some of the matters strongly opposed the applications on the ground that, no reasonable cause is mentioned for condoning the delay periods.
