PER COURT :

A. Order in Application/s for Delay :

1. It appears that the delay applications are wrongly filed. In fact, there is no delay in filing the appeals. Hence, Civil Applications are disposed of.

B. Order in Application/s for Stay :

1. Mr. Swami, learned Advocate appearing for the applicants points out that in the group of matters arising out of the same acquisitions, this Court has granted interim stay to the execution of the award subject to deposit of 75% of the compensation amount. He placed reliance on the order dated 24th September, 2021 passed in Civil Application No.6543/2021 in First Appeal No.1061/2021.
2. Considering the submissions advanced, Civil Applications are disposed of, subject to deposit of 75% of the amount of award including interest and cost within a period of twelve weeks.
