PER COURT:

1. The present first appeals are filed by the claimants for enhancement of compensation. They have filed the applications for condonation of delay of 439, 440 and 449 days in respective matters. The learned counsel submits that the land of the applicants are compulsorily acquired and that due to their bad financial position they are

unable to file the appeal within limitation. The applicants are poor agriculturists. They are unable to make necessary arrangements for court fees and necessary legal expenses. Their substantial rights would be defeated if the delay is not condoned. The delay caused is bonafide and not intentional.

2. In view of the same, the delay is condoned. The civil applications for condonation of delay are allowed and disposed of.

3. Issue notice in the first appeals to the respondents, returnable on 20.12.2023. The learned AGP waives service of notice on behalf of respondent no.1.
