ORDER
(9th December, 2023)

1. In First Appeal No. 968 of 2018 the claimant Zhugrabai is identified by learned Advocate Mr. More. Though there is some discrepancy in her name in Aadhar Card, this panel has verified that the lady in the photograph appearing on the Aadhar card is present before this Court.
2. Parties have entered into compromise. The compromise is duly signed by the parties and identified by the respective counsels is placed on record. The claimants have agreed to accept the compensation as per

the compromise memo which is marked as 'X' for identification. The appeals filed by the claimants stand disposed of in terms of compromise.

3. Acquiring Body undertakes to deposit amount within one year. Claimants are permitted to withdraw the amount deposited by the Acquiring Body with interest thereon in this Court.

4. The claimants make statement that except them and signing parties, there are no stakeholders in the subject matter of proceedings in hand.

5. No order as to costs.

6. Refund of Court fees be proceeded as per rules.
