PER COURT :-

1. The learned A.P.P has vehemently argued that instead of approaching the Special Court, the applicant has directly approached this Court. The judicial discipline has not been followed. The applicant is seeking bail on parity, as the Hon'ble Supreme Court has granted bail to the prime accused. As general practice and judicial discipline, every application should be filed before the original Court. The learned counsel for the applicant has correctly pointed out that the Sessions Court and the High Court have concurrent jurisdiction under Section 439 of the Cr.P.C. However, there should not be unwarranted precedent. The same relief can be sought before the trial Court. Hence leave granted to withdraw this application with a liberty to approach the Special Court.
2. With the above observations, all applications stand disposed of.
3. The learned Special Court should decide the applications within two weeks from the date of filing of the application subject to co-operation of all concerned.
