MINUTES OF THE ORDER

1. *The Respondent No. 1 and 3 agree that the Petitioner shall retire on completion of 60 years of age.*
2. *The Petitioner shall continue in service on regular basis as Technical Assistant beyond 30.06.2023 and shall superannuate at the age of 60 years i.e. on 30.06.2025 or such higher age of retirement, as fixed by law.*
3. *The Petitioner shall be entitled to all the benefits until superannuation, including promotion, increments, gratuity, revised pay scale, dearness allowance, leave and all monetary and other benefits.*

7. Accordingly, at the request of the Petitioner, Respondent No. 1 and Respondent No. 3, we dispose of the Writ Petition in terms of the minutes of the order marked as 'A' for identification.
