1. By our order dated 20/2/2023, we had directed the Respondents to take a decision on the invocation of the bonds furnished by the original Petitioners within three months. The Applicants-original Respondents now seek extension of further three months.

2. The learned Advocate General states that the initial period of three months expired on 20/5/2023. Therefore, if the extension of one month is now granted, a decision will positively be taken in the matter.

3. The reasons stated in the Applications is that Dr. Mahesh Kamble, Joint Director, Academics, who was well versed with the
