5. The learned Counsel for the applicant on instructions submits that the applicant has already deposited an amount of Rs.25 lakhs with the liquidator – Shivajirao Bhosale Co-operative Bank.

6. Considering the overall facts and circumstances of the case and in view of the Affidavit-cum-undertaking filed by the applicant, I am inclined to release the applicant on anticipatory bail. Hence, the following order is passed :

- (i) Application is allowed.
- (ii) In the event of arrest of the applicant - Sanjay Mahadev Jagtap in Crime No. 139 of 2021 registered at Shikrapur Police Station, Pune for the offences punishable under Sections 420, 409, 465, 467, 468, 471, 120-B of Indian Penal Code, he shall be released on bail on furnishing P.R. Bond in the sum of Rs.25,000/- with one or two sureties in the like amount.
- (iii) The prosecution is at liberty to file application for cancellation of anticipatory bail in case the applicant commits breach of undertaking.
