**INTERIM APPLICATION NO. 3613 OF 2022**

1. Mr. Patil for State/Respondent No.1 as well as Special Land Acquisition Officer states the law is very clear and applicant should be entitled to the relief as prayed for in prayer clause – (A). Prayer clause – (A) reads as under :

*(A) This Honourable High Court be pleased to permit the Applicants to amend and claim compensation at the rate of Rs.5,000/- per square meter thus totally claiming further enhancement of Rs.4,050/- in Cross Objections.*

2. Application therefore allowed and stands disposed.
3. Amendment to be carried out and amended claim to be served within two weeks.
4. Deficit court fees to be paid within three weeks.
