1. The above Interim Application is filed seeking certain amendments

to the Writ Petition.

2. The above Writ Petition was admitted by this Court vide order dated 18th October 2022. In the said order, liberty was granted to the Petitioners to take inspection of the documents relied upon by the State of Maharashtra and apply for amendment, if warranted. The Petitioners have taken inspection and after that have filed the present application seeking amendments.
