CONSENT TERMS

1. The Appellant filed application no. M.A.C.P No. 114/2017 before Learned Motor Accident Tribunal, Solapur for claiming compensation of Rs.75,00,000/- against the Respondents.

2. The Claim Petition was allowed vide Judgment and Award dated 2.1.2019, directing the Respondents to pay compensation to the tune of Rs.18,87,416/- with interest @ 9% per annum from 30.10.2017.

3. The Respondent no.3 (New India Assurance Co. Ltd) deposited the amount and satisfied the order dated 2.1.2019 passed in MACP NO. 114 of 2017 .

4. The Appellant claimant has preferred aforesaid First Appeal for enhancement of the compensation against the Respondents.
5. During the pendency of the aforesaid Appeal, the Appellant and the Respondent Nos. 3 had meetings for negotiations and settlement of dispute once for all wherein the parties have reached to an amicable settlement out of the court.
6. The Respondent no.3, the New India Assurance Co. Ltd shall deposit Rs.29,00,000/- (Rupees Twenty nine lac Only) before Learned Motor Accident Tribunal, Solapur within 6 weeks from passing of the order before Lok Adalat held on 9.12.2023. This amount is in addition to the amount already paid by the respondent insurance company as stated above.
7. The Appellant Nos. 1 & 2 shall have no further claims whatsoever against Respondent no.3, New India Assurance Company in any Court/ Tribunal/ Forum/ Judicial/ Quasi-Judicial Authority in India with respect to death of Late Anushri Ajay Bagewadi on 2.7.2017
8. The court fee refund certificate will be issued in favour of appellant No. 1.

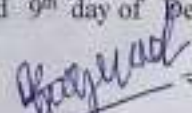

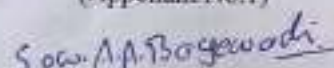

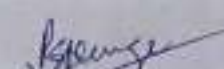
