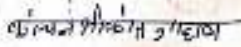

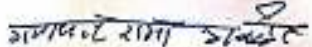
of the Tahasildar granting removal of obstruction on the footway. The petitioners state that the Petitioner No. 2 died during the pendency of this petition.

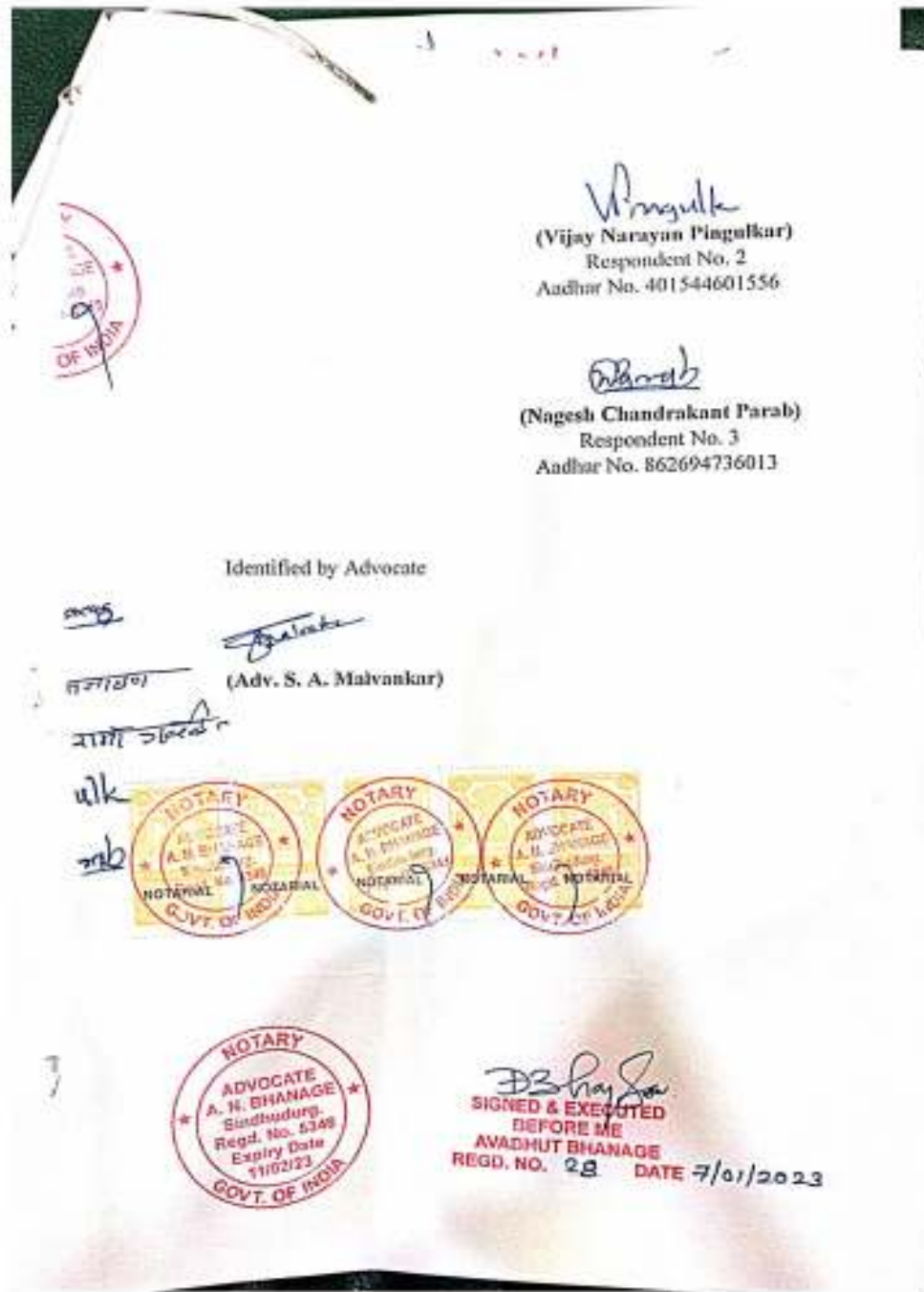
