(E) From the month of November-2023 the Petitioner will deposit a sum of Rs.6,250/- per month, in the bank account of the Respondent No.1 and will continue to deposit the said amount every month on the 10th day, till further orders.

(F) This amount is fixed calculating the 25% of the pension amount to be received by Petitioner from June-2023, would be the monthly maintenance amount to the Respondent No.1.

(G) If there is increase in the pension amount there will be an simultaneously increase of 25% on the amount of the maintenance to the Respondent No.1.

2. This Writ Petition is accordingly disposed of, on above terms.
