1. Learned counsel for the petitioners would submit that these petitions are filed praying for similar reliefs. For convenience, the prayers in Writ Petition No.15339 of 2023 are required to be noted, which read thus:

“a) That, this Hon’ble Court may kindly be pleased to issue writ, inter alia, directing the Respondents to de-freezing of the bank account number 0082002100078673 of the Petitioner-Company with Punjab National Bank, Branch Mumbai.

b) For such further and other relief’s as in the circumstances this Hon’ble Court may deem fit and proper and;

c) costs.”

2. It is submitted that a fresh attachment order Form GST DRC-22 dated 3 January 2023 was issued under Section 83 of the Central Goods and Services Tax Act (for short ‘**CGST Act**’), provisionally attaching the Bank Account of the petitioners. In this view of the matter, learned counsel for the petitioners would submit that liberty be granted to the petitioners to withdraw these petitions and to file appropriate petitions to assail the actions of the respondents including the provisional attachment of the petitioners’ Bank Account by a fresh order dated 3 January 2023.

3. We accept the request as made on behalf of the petitioners. We permit the petitioners to withdraw these petitions with liberty to the petitioners to file fresh petitions as prayed for.

4. All contentions of the parties are expressly kept open.

5. Disposed of in the above terms. No costs.
6. Interim applications would also not survive, the same stand disposed of.
