1. Mr. Ojas Deolankar, learned Counsel appearing for the Petitioner tenders affidavit dated 21st December 2023 of Mr. Zubair Rashid Khan on behalf of Petitioner No.1- Trust. The said Mr. Zubair Khan is personally present in the Court.

2. Mr. Ojas Deolankar, learned Counsel appearing for the Petitioner on the basis of said affidavit dated 21st December 2023 as also on the basis of the instructions of Mr. Zubair Khan, the Petitioner, states that the Petitioner is withdrawing the application bearing Exhibit 7 filed in respective Revisions. As Application bearing Exhibit 7 filed in the respective Revisions are withdrawn, the impugned orders passed below Exhibit 7 dated 24th August 2023 in respective Revisions passed by learned Joint Charity Commissioner, Pune are quashed and set aside.
