1. Rule. Rule made returnable forthwith.

3. The proposal seeking approval to the transfer of the Petitioner from an un-aided post of Assistant Teacher to an aided post has been made on 21.08.2023. The said proposal is pending with the Education Officer (Secondary).
4. In these facts the Writ Petition is disposed of by directing Respondent No.5-the The Education Officer (Secondary) to consider and decide the said proposal in accordance with law within a period of eight

weeks of receiving a copy of this Order. The proposal shall be decided in accordance with law, after granting an opportunity of hearing to the Petitioner. In case approval is granted, all consequential benefits including grant of Shalarth ID shall be made applicable to the Petitioner.
