2. We see no reason to interfere. The impugned notices (of 30th October 2023 in one case) are simply show-cause notices. Each gives the Petitioner in question 15 days to show cause and produce documents. There is no ground made out to interfere with the show-cause notices. No order has been passed.
3. The entire attempt is clearly to prevent orders being passed on merits by the authority concerned. The Writ Petitions are rejected.
