ORAL JUDGMENT (Per Sunil B. Shukre, J.)

Heard. **Rule.** Rule made returnable forthwith.

Heard finally by consent of learned counsel for the parties.

2. We find that the petitioners are the teachers, who have completed period of more than three years at difficult stations and, therefore, they are the teachers, who fall in category-3 mentioned in Clause 1.7 in G.R. dated 7th April, 2021. This clause confers right upon the teachers, to seek their transfers if they have put in service for more than three years in difficult area. As stated just now, the petitioners fulfil this criteria. It would then follow that the transferring authority would have to go by the procedure prescribed in Clause 4.3 and other relevant clauses including clause 4 of the G.R. dated 7th April, 2021. Clause 2.3 requires the transferring authority to identify the vacancies in the schools so that the suitable options for accommodating different teachers, who are eligible, can be granted and transfers made in terms of G.R. dated 7th April, 2021. Such being the factual position and also the position emerging from a plain reading of provisions made in G.R. dated 7th April, 2021, we are of the view

that the petitioners are a category of teachers who need to be given permission to login and make online application for their transfers to their preferred places, although which places the petitioners are to be transferred to is a decision which is exclusively within the discretion of transferring authority to be exercised within the parameters of law. Our such view is fortified by the view taken by the Coordinate Benches of this Court in cases of *Datta Rushiket Salunke Vs. The State of Maharashtra (Writ Petition No.13344/2022, decided on 6.1.2023) at Aurangabad and Writ Petition No. 7667/2022 and other connected matters (Sachin Subhashrao Tambakhe and others Vs. State of Maharashtra, decided on 31.01.2023 at Nagpur.*

3. In view of the above, writ petitions are partly allowed.
4. The transferring authority is directed to identify the vacancies in accordance with the provisions made in the G.R. dated 7th

April, 2021 and in the light of the observations made herein-
above and permit the petitioners to login and submit their online
applications. We further direct the transferring authority to com-
plete the online transfer process and give effect to the transfers
made within the time prescribed in clause 5.9 of the G.R. dated
7th April, 2021.

5. Rule is made absolute in the above terms. No costs.
