ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Temple Festival of Arulmigu Sri Maga Mariamman Temple, Rasampalaiyam Village, Perundurai Taluk, Erode District on 11.01.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 21.12.2022.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Temple Festival of Arulmigu Sri Maga Mariamman Temple, Rasampalaiyam Village, Perundurai Taluk, Erode District on 11.01.2023, the petitioner has sent a representation, dated 21.12.2022 to the respondent Police.
