With regard to the rectification to be made based on the correction that has been made in the UDR patta issued in this regard for the land in question, the petitioner had given a representation to the respondents especially to the second respondent on 26.04.2022. However, since it relates to Natham property, orders to be passed by the Revenue Divisional Officer. According to the learned counsel appearing for the petitioner that the said representation was transferred by the second respondent to the first respondent.
