ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Palayapettai Village Arulmigu Sree Mariyamman Temple Pongal Festival at Natrampalli Taluk, Tirupathur District, on 16.01.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 30.12.2022.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Palayapettai Village Arulmigu Sree Mariyamman Temple Pongal Festival at Natrampalli Taluk, Tirupathur District on 16.01.2023, the petitioner has sent a representation, dated 30.12.2022 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3.The learned Government Advocate (Criminal side) appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 30.12.2022 and pass suitable orders based on the above said circular.
