ORDER

The Writ Petition has been filed to direct the respondent to grant permission to conduct cultural Programme (Adal Padal Nigalchi) in the event of Vadakkalur Village Arulmigu Sree Karupparayan Temple 40th year Pongal Festival at Annur Taluk, Coimbatore District, on 16.01.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 27.12.2022.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Vadakkalur Village Arulmigu Sree Karupparayan Temple 40th year Pongal Festival at Annur Taluk, Coimbatore District on 16.01.2023, the petitioner has sent a representation, dated 27.12.2022 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.
