The Writ Petition has been filed to direct the respondent to give permission to conduct the cultural programme (Adal Padal Nigalchi) in the event of Rangampalayam Arulmigu Sri Maha Mariamman Koil at Kasipalayam, Erode District on 04.01.2023 between 6.00 pm to 11.00 pm based on the petitioner's representation dated 03.12.2022.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 04.01.2023, from 6.00 p.m. to 11.00 p.m., in the Temple Festival of Rangampalayam Arulmigu Sri Maha Mariamman Koil at Kasipalayam, Erode District, the petitioner has sent a representation, dated 03.12.2022 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 03.12.2022 and pass suitable orders based on the above said circular.
