ORDER

The Writ Petition has been filed to direct the respondent to grant permission and Police protection to conduct cultural Programme (Adal Padal Nigalchi) in the event of Temple Festival of Bandarahalli Arulmighu Sri Periyandavar Koil at Karimangalam, Dharmapuri District on 16.01.2023 between 06.00.p.m to 11.00.p.m., by considering the petitioner's representation dated 03.12.2022.

2.The learned counsel appearing for the petitioner submitted that in order to conduct the cultural programme in the event of Temple Festival of Bandarahalli Arulmighu Sri Periyandavar Koil at Karimangalam, Dharmapuri District on 16.01.2023, the petitioner has sent a representation, dated 03.12.2022 to the respondent Police. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 03.12.2022 and pass suitable orders based on the above said circular.
