ORDER

2.This writ petition has been filed seeking for a limited relief.

3.The petitioner seeks for early disposal of his Appeal pending on the file of the first respondent. The Appeal is dated 28.02.2022 and has been filed by the petitioner, aggrieved by the order of the second respondent dated 23.07.2021, wherein punishment has been imposed, namely, stoppage of one increment without cumulative effect, on the petitioner.

7.With the aforesaid direction, this writ petition stands disposed of.
