ORDER

By consent of both the parties, this writ petition has been taken up for final disposal at the admission stage itself.

2.This writ petition has been filed for a Mandamus seeking for a direction to the respondents to settle the interest for the belated payment of retirement benefits along with Gratuity, Earned Leave, Commutation of



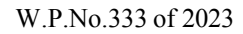

Pension and other retirement benefits payable to the petitioner with 18% interest per annum, within a time frame to be fixed by this Court.

3.The grievance of the petitioner in this writ petition is that his retirement benefits were paid belatedly by the respondent Transport Corporation. According to him, he is entitled for interest for the belated payments.

4.Heard Mr.N.Sudhagar Nagaraj, learned counsel for the petitioner, Mr.R.U.Dinesh Rajkumar, learned Additional Government Pleader, who accepts notice on behalf of the first respondent, Mr.M.Aswin, learned Standing Counsel, who accepts notice on behalf of the respondents 2 and 3 and Mr.C.S.K.Sathish, learned counsel, who accepts notice on behalf of the fourth respondent.

5.It is settled law that as laid down in various decisions of this Court that in case of belated payments of retirement benefits, the employer is liable to pay interest at the rate of 4% per annum. The petitioner has given a
