### **ORDER**

The Writ Petition has been filed to direct the first and second respondents to grant permission to conduct the cultural programme of Adal Padal on 02.02.2023 at 06:00 pm to 11:00 pm at “Sri Kariya Kaliamman Temple Kundam & Car Festival” Korakattupudhur Village, Kadukkampalayam Post, Gobichettipalayam Taluk, Erode District by consider and pass orders on the representation dated 27.12.2022 made by the petitioner within the time frame as may be fixed by this Hon'ble Court.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 02.02.2023, from 6.00 p.m. to 11.00 p.m., in the “Sri Kariya Kaliamman Temple Kundam & Car Festival” Korakattupudhur Village, Kadukkampalayam Post, Gobichettipalayam Taluk, Erode District, the petitioner has sent a representation, dated 27.12.2022 to the second respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent police is hereby directed to consider the representation of the petitioner, dated 27.12.2022 and pass suitable orders based on the above said circular.
