The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 15.01.2023, from 6.00 p.m. to 11.00 p.m., in the “Sri Kondathu Omkalamman Temple Gundam Festival” A.Karatupalayam Village, Vellalapalayam Post, Bhavani Taluk, Erode District, the petitioner has sent a representation, dated 23.12.2022 to the second respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent police is hereby directed to consider the representation of the petitioner, dated 23.12.2022 and pass suitable orders based on the above said circular.
