ORDER
(By *S.Vaidyanathan,J.*)

When the matter is taken up for hearing, learned Special Government Pleader, appearing for the respondents, has filed a Compliance Affidavit of the respondents, regarding the compliance of the order, against which this Contempt Petition is filed. Paragraph Nos.4 and 5 of the said Compliance Affidavit are scanned below for ready reference :

4. It is humbly submitted that the order passed by the Hon'ble Court is complied with. I state that pursuant to the Order passed by the Hon'ble Court and based on the proceedings of the Village Administrative Officer and Revenue Divisional Officer dated 01.04.2022 and 11.08.2022, the Government Canal, comprised in S.No.108/2 - 0.09.5 Ares was surveyed and encroachments were removed on 11.08.2022 by the 1st respondent and 2nd respondent along with Deputy Tahsildar, Revenue Divisional Officer, Village Administrative Officer in the presence of the writ petitioner as well as the respondents 6 and 7 in writ petition namely, Pachayappan and Rani.
5. It is further submitted that pursuant to the filing of contempt petition, with regard to S.No.108/2 measuring 0.09.5 ares which is classified as Vellavari Kalvai, a survey inspection was conducted on 05.04.2023 and it was confirmed that there is no encroachment at present. I state that the order of this Hon'ble Court was complied with in toto and to its letter and spirit.
