ORDER

This Contempt Petition has been filed complaining wilful disobedience of the order dated 10.12.2021 in W.P.No.12260 of 2021 by the respondent.

2. During the course of hearing, on behalf of the respondent, the counter affidavit has been filed. It is stated in the said counter affidavit that the order of the Court is complied with by issuing a cheque bearing No.822003 dated 24.04.2023 for an amount of Rs.14,020/- for PF interest; another cheque bearing No.822079 dated 24.04.2023 for an amount of Rs.16,634/- for Gratuity interest and another cheque bearing No.979694 dated 02.12.2022 for an amount of Rs.10,101/- for EL Encashment interest.

3. In the said counter affidavit, the respondent further submits that the order of the Court is not complied with within a stipulated time due to the financial crux and exigency prevailing in the Transport Corporation and they could not mobilize funds due to Covid-19 pandemic also, as the buses were not operated and only very few number of buses were operated which met a huge loss to the Corporation.

4. The respondent tendered his unconditional apology for the delay caused in implementing the order of the Court in true letter and spirit.

5. Having considered the facts and circumstances of the case and on consideration of the averments made in the affidavit filed by the respondent, this Court satisfied that the respondent has complied with the order passed by this Court.

6. This Court is also of the opinion that the unconditional apology tendered by the respondent is bonafide and as such, it has to be accepted.

7. For the reason stated above, in my considered view further adjudication in this contempt case is unwarranted.

8. Accordingly, this Contempt Petition is closed.
