Prayer: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records relating to the order dated 05.04.2012 passed by the second respondent herein on the basis of the enquiry report dated 26.07.2011 submitted by the fourth respondent herein and to quash the same and direct the respondents 1 to 3 to reinstate the petitioner as the Head/Dean, Department of Visual Communication along with the post of Consultant and Public Relationship Officer in the Institution of the respondents 1 to 3 with all the service and monetary benefits including the arrears of pay and future pay at the rate as prescribed under the University Grants Commission within the time frame as fixed by this Hon'ble Court.
