We have heard Mr.A.Arun, learned counsel for the petitioner, Mrs.R.Anitha, learned Special Government Pleader, for respondent Nos.1 to 6, Mr.A.V.Raja, learned counsel for respondent No.7 and Mr.M.Sudhan, learned counsel for respondent No.12.

2. The petitioner seeks removal of encroachments on the Government Wari Poramboke and the waterbody lands in the subject writ area.

3. The learned Special Government Pleader submits that a survey would be conducted on 26.12.2023. After completing the survey and depending upon the report of the survey, the further steps would be taken in accordance with law.

4. After the survey report is received, the same may be acted upon expeditiously by the authorities concerned. The process after the survey report shall be commenced preferably within six weeks.
