4. A bare perusal of the materials available on record, would indicate that the petitioners have filed a Suit in O.S.No.267 of 2012 on the file of the District Munsif, Perambalur, for injunction. Considering the fact that the matter pertains to the year 2015, this Court is of the considered view that the petitioner is not interested in prosecuting the matter any more. Accordingly, this writ petition is dismissed as infructuous. No costs. Consequently, the connected Miscellaneous Petitions are closed.
