Prayer:- Writ Petition filed under Article 226 of the Constitution of India, 1950, praying to issue a Writ of Certiorarified Mandamus, calling for the entire records relating to the impugned orders passed by the First respondent in G.O. No. 131 Cooperation, Food & Consumer Protection Department dated

04.06.1996 and the consequential impugned orders passed by the Third Respondent in his proceedings Na.Ka.5608/2006 Tho.Ve.Va dated 23.08.2006 and by the Fourth Respondent in his proceedings Na.Ka.No.1/2006 dated 30.06.2006 quash the same as illegal and null and void and consequently direct the Second to Fourth Respondents to settle the withheld terminal benefits of Rs. 3,35,225/- with interest at 12% p.a for the belated payment from the date of retirement.

ORDER
