In respect of landed property at Survey No.403 situated at Mangalam Village, Tiruppur District, the petitioner had given application cum representation dated 17.10.2022 to survey the land and to identify the four boundaries to the 3rd respondent Tahsildar, necessary fee also has been paid by the petitioner to that effect. Therefore, in order to consider the said application and to do the needful, the petitioner has moved the present writ petition with the aforestated prayer.

3. Heard Mr.M.G.Ramachandiran, learned counsel appearing for the petitioner and Mr.R.P.Muruganraja, learned Government Advocate appearing for the respondents.

4. The learned Government Advocate would submit that, the said application submitted by the petitioner dated 17.10.2022 would be
