WEB COPY The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct Cultural Programme viz., (Adal Padal Nigalchi) program in the event of Valparai Town Arulmighu Sree Subramaniya Swamy Temple Festival at Valparai Taluk, Coimbatore District on 05.02.2023 between 6 pm to 11 pm by considering the petitioner's representation dated 04.01.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 05.02.2023 between 6 pm to 11 pm to conduct Cultural Programme viz., (Adal Padal Nigalchi) program in the event of Valparai Town Arulmighu Sree Subramaniya Swamy Temple Festival at Valparai Taluk, Coimbatore District, the petitioner has sent a representation, dated 04.01.2023 to the respondent. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 04.01.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
