WEB COPY The Writ Petition has been filed to direct the respondent to give permission and police protection to conduct Cultural programme (Adal Padal Nigalchi) in the event of Vannathipatti Village, Gandhi Nagar Arulmigu Sree Om Sakthi Swamy Temple Thaipongal Festival at Pennagaram Taluk, Dharmapuri District on 16.01.2023 between 6pm to 11 pm by considering the petitioner's representation dated 03.01.2023.

The learned counsel appearing for the petitioner submitted that in order to conduct cultural programme on 16.01.2023 between 06:00 pm to 11:00, in the event of Vannathipatti Village, Gandhi Nagar Arulmigu Sree Om Sakthi Swamy Temple Thaipongal Festival at Pennagaram Taluk, Dharmapuri District, the petitioner has sent a representation, dated 03.01.2023 to the respondent. But, the same has not been considered so far. Hence, the present writ petition has been filed.

3. The learned Government Advocate (crl.side), appearing for the respondent submitted that the respondent police has received the representation of the petitioner and the same is pending for consideration.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondent police is hereby directed to consider the representation of the petitioner, dated 03.01.2023 and pass suitable orders based on the above said circular.

6. With the above direction, this Writ Petition is disposed of. No costs.
