ORDER

The prayer sought for herein is for a writ of mandamus directing the 1st respondent to consider the representations of the petitioner dated 07.08.2020 and 26.08.2020 to survey the land by issuing proper notice to the adjacent land owners i.e., the 4th and 5th respondents herein within a stipulated period of time.

In respect of the property at S.No.27 at Athanavur Village, Yelagirimalai, Tirupathur Taluk and District, the petitioner has made an application to the first and second respondents to survey the land to identify the four boundaries and in this regard, application has been submitted on 07.08.2020 with necessary fee. Therefore, in order to consider the same, the present writ petition has been filed.
